APPROVAL OF MAP 19057 FOR WATER APPROPRIATION A-19253

WATER DIVISION 2-C

BACKGROUND

1. On May 13, 2014, Jerry, Virginia, Mike, Richard and Terry Gokie filed in the Department application A-19253 for a permit to appropriate water.
2. On September 15, 2014, Jerry Gokie filed in the Department map number 19057 showing land proposed to be irrigated under application A-19253.

ORDER

IT IS HEREBY ORDERED:

1. Map number 19057 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19253 as depicted on map number 19057:

Appropriation A-19253 authorizes the appropriator the use of 273 acre-feet annually from Jerry Gokie Reservoir (storage appropriations A-19251 and A-19252) from a pump site located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 10, Township 31 North, Range 12 West of the 6th P.M. in Holt County, as depicted on map number 19057.
4. Appropriation A-19253 provides supplemental water to irrigate land under surface water appropriations A-18691R and A-12975R.

5. The appropriator is bound by all terms and conditions of the approval of application A-19253.
